VISITORS:

ENGINEER'S REPORT:

 Act 410-Water Sector Program- Stephanie emailed an update. USDA requires a Phase I Environmental Site Assessment on all properties acquired for a project that will receive funding. She provided three proposals from companies to perform the site assessment. Motion by Chris, seconded by Eddie to authorize President James Alleman to execute an agreement with Hydro-Environmental at a cost of \$2,000.00. Motion passed.

OLD BUSINESS:

- Well repair Griner Drilling sent a quote of \$19,250.00 to repair the well by putting cement at the bottom to try and prevent sand from getting in. They estimate this repair will hold for 5-10 years. In 2020, they did a camera survey on Well #1 and #2, and replaced the pumps and motors. Curt suggested that we add a new check valve at the bottom of the pipe; it will cost around \$1,000-\$2,000.
- Call to Stephanie: If we have to replace the well, we would need to increase the well size to at least 8" to supply a water tower. She will get more information on that at the next meeting.
- Kristin will get an updated quote from Griner to repair the well and replace the pump, motor, and check valve.
